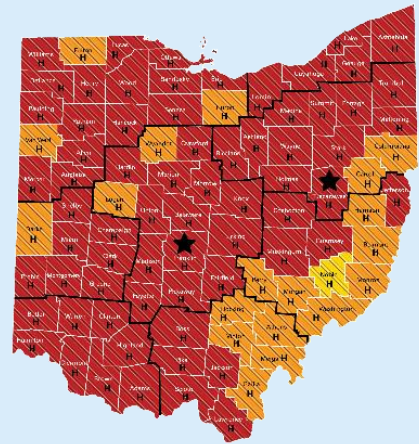

TALKING POINTS FOR YOU

Adapt these to reflect your specific situation

- Ohio is currently experiencing a more intense surge in COVID-19 cases, hospitalizations, and ICU admissions across the entire state.
- We care about our employees, and those in our communities, including the healthcare workers putting their lives on the line for all of us.
- The ability for us to keep working depends on all of us being safe both on and off the clock.
- Businesses have taken steps to prevent spread in the workplace, and we are committed to doing all we can including doubling down on mask requirements for employees and customers.
- We know that much of the recent spike is through social gatherings. We urge everyone to remember that while you may think your bubble is just your closest friends, it's much bigger. It's their friends, it's where you eat or shop, and where your friends eat and shop. Community spread is real, and it is dangerous.
- Now is not the time to let up. We are asking our employees, their families and the entire community to stick to the basics: wash your hands; wear your mask even when you're with friends and family; stay socially distanced; and stay home when you are sick.

WAYS COMMUNITY LEADERS CAN HELP

- Post on social media to describe how you are working to keep your employees and customers safe (and what they can do to help you maintain a safe environment) using the suggested hashtags.

- Send out regular communications to your network and ask members to post personal messages on social media. This could include a regular newsletter or message to your full company/organization.
- Leverage relationships with “local celebrities” and ask them to promote your efforts as well.
